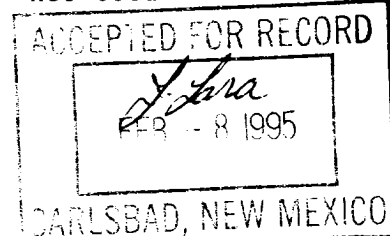
Spud 17-1/2" hole at 5:00 p.m. MST. Drlg ahead.

01/06/95:

Depth 427'. RU casing crew and ran 10 jts 13-3/8" 48# H-40 ST&C casing and set at 422'. Cemented w/ 100 sx C1 "C" containing 6% gel, 1/4 pps Cello-seal, and 2% CaCl2. Tail w/ 225 sx C1 "C" + 2% CaCl2. Plug down at 12:18 p.m. Circ'd 53 sx to pit. WOC.

01/07/95:

Cut casing off and NU BOP. TIH and test casing to 600 psi, ok. WOC total of 24 hours. Resume drilling operations.
