Circ 234 sxs to pit. Bumped plug @ 11:45 pm 7/30/95. Install wellhead. NU BOP's and test to 5000 psi. WOC 28-3/4 hrs. Test 9-5/8" csg to 3000 psi for 30 min. from 4:30 am-5:00 am 8/02/95. Drlg 8-3/4" hole.
