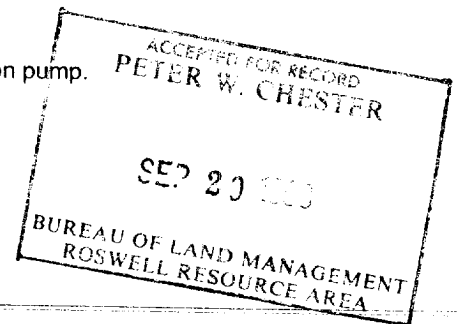

09/04/98 Frac perfs 6426'-36' w/ 73,500# 16/30 sand. Flow well back.

09/05/98 Circ well clean. Swab test.

09/10/98 Latch onto RBP @ 6624' & POOH. LD RBP. Run production equipment. Put well on pump.
