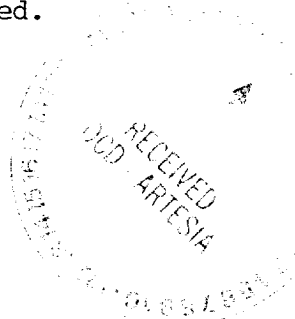

Lindenmuth & Associates, Inc. requests permission to set 800' of 8 5/8" surface casing. The "Application for Permit to Drill" was approved for 500'. The extra 300' of surface casing will prevent sloughing problems experienced by offset wells. The surface casing shoe will not be set below or in a salt section. If a salt section is found above 800', then the surface casing setting depth will be reduced.
