

The Diverse "23" Federal #1 was spud 1/15/2000. A 12 1/4" hole was drilled & new 8 5/8" 23#/ft. M-50 casing was set @ 820'. The surface casing was cemented to the surface with 742 sx Class C cement. Oil shows were recorded in the Delaware-Williamson formation and 5 1/2" 15.5#/ft. M-50 casing was set at 5226' in a 7 7/8" hole. The production casing was cemented with 1100 sx Class C cement. The cement was not circulated to the surface but pump pressures and returns indicate the cement top is less than 200'. A cement bond log will be run to determine the actual cement top.
