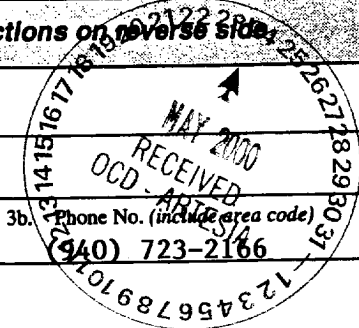

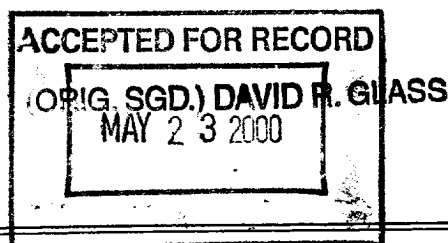

4-5-2000: Spud 12 1/4" surface hole @ 7:00 PM. Drill to 815' KB. Run 20 jts 8 5/8" new Maverick, J-55, 24 lb/ft surface csg. Set csg at 815' KB. Cement with 260 sx Premium Plus w/2% CC. Circulate 60 sx to pit. Plug down at 9:45 AM 4-6-2000. WOC 18 hrs.
