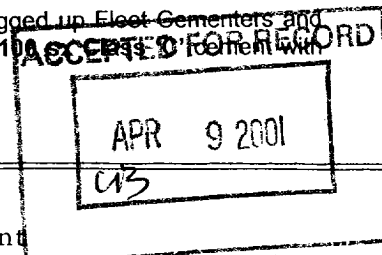

03/12/2001 Ran 20 joints 8 5/8" 24 # ST&C casing and set at 880'. Rigged up Fleet Cementers and pumped 400 sx Class 'C' cement (no returns). Picked up 1" string and go in hole and tag cement at 472'. Pumped 50 sx Class 'C' cement with 2% CaCl. Go in hole and tag top of cement at 456'. Pumped 50 sx Class 'C' cement with 4% CaCl. Go in hole and tag top of cement @ 360'. Pumped 50 sx Class 'C' cement with 4% CaCl. Go in hole and tag top of cement @ 389'. Pumped 26 sx Class 'C' cement with 4% CaCl. Go in hole and tag top of cement @ 316'. Pumped 26 sx Class 'C' cement with 4% CaCl. Go in hole and tag top of cement @ 266'. Pumped 50 sx Class 'C' cement with 4% CaCl. Go in hole and tag top of cement @ 204'. Pumped 100 sx Class 'C' cement with 4% CaCl. Go in hole and tag top of cement @ 75'. Dumped 1 yard ready mix down back side of casing and filled annulus to surface.

03/16/2001 Ran 73 joints of 5 1/2" 15.5# LT&C casing. Set at 3089'. Rigged up Fleet Cementers and pumped 150 sx FCI lite Class 'C' cement w/ 3% salt & 1/4# celloflake and 100 sx Class 'C' cement with 2% CaCl. Plug down at 9:00 PM 03/16/01.
