Yates Petroleum Corporation respectfully requests permission to make the following changes to this well:
Change BOP test procedure on 13 3/8" casing. We will nipple up a 3,000 psi BOP on the 13 3/8" and 8 5/8" casing strings. On the 13 3/8" we will test the BOP and 13 3/8" together (no test plug) to 1,200 psi (70% of the 13 3/8" burst pressure. After nipping up on the 8 5/8" casing the BOP will be tested to 3,000 psi.

Also, the 5 1/2" casing design in the APD listed 15.5# L-80 from 100'-6,900'. This should in fact be 15.5# J-55
