This plan is submitted with the application for permit to Drill the above described well. The purpose of the plan is to describe the location of the proposed well, the proposed construction activities and operations plan, the magnitude of necessary surface disturbance involved, and the procedures to be followed in rehabilitating the surface after completion of the operation so that a complete appraisal can be made of the environmental effects associated with the operation.

1. EXISTING ROADS:

- A. <u>Exhibit "A"</u> is a portion of a road map showing the location of the proposed well as staked. The well is approximately 30 miles North of Roswell, N.M.
- B. <u>Directions</u>: Heading North out of Roswell, New Mexico on U.S. 285 for approximately 23 miles and turn left on county road just before mile marker 137 (Cottonwood Road). Go approximately 8.2 miles to gravel pit, turn right the go 2 7/8 mile access road is on left.
- 2. PLANNED ACCESS ROAD:
 - A. Length and Width: 2 mile long and 14' wide.
 - B. Surfacing Materials: Sand and gravel where needed.
 - C. Turnouts: one
 - D. Maximum Grade: No more than 3%.
 - E. Drainage Design: Road will have drainage ditches on both sides and a crowned top, with culverts and/or low water crossings as necessary.

- F. Culverts: None
- G. Cuts and Fills: none
- H. Gates, Cattleguards: none
- I. Top Soil: Very little

3. LOCATION OF EXISTING WELLS:

A. A map indicating the location of adjacent wells is attached.

4. LOCATION OF EXISTING AND/OR PROPOSED FACILITIES:

- A. <u>See Exhibit "A"</u> for location of existing lease wells. If the well is commercial, production facilities and tank battery will be constructed.
- B. Cuts and Fills: Less than 10'of cut and fill will be required for the pad size of 250' X 250'. (see Exhibit "F")
- C. <u>Top Soil</u>: Any top soil which can sustain plant vegatation will be bladed and piled for future rehabilitation.

5. LOCATION AND TYPE OF WATER SUPPLY:

- A. Water will be purchased from a commercial source and trucked to the location over existing and proposed access roads.
- 5. SOURCE OF CONSTRUCTION MATERIALS:
 - A. Federal pit located in the SW/4NW/4 Sec. 15-6S-22E.
- 7. METHODS OF HANDLING WASTE DISPOSAL:
 - A. Drill cuttings will be disposed of in the drilling pits.
 - B. Drilling fluids will be allowed to evaporate in the drilling pits until the pits are dry.
 - C. Water produced during test will be disposed of in the drilling pits. Oil produced during tests will be stored in test tanks until sold.

- D. Current laws and regulations pertaining to the disposal of human waste will be complied with.
- E. Trash, waste paper, garbage, and junk will be buried in a separate trash pit and covered with a minimum of 24 inches of dirt or deposited in an approved sanitary landfill. All waste material will be contained by a netted container to prevent scattering by the wind. Location of the trash pit is shown on Exhibit "C".
- F. All trash and debris will be buried or removed from the well site within 30 days after finishing drilling and/or completion operations.
- 8. ANCILLARY FACILITIES:
 - A. None necessary
- 9. WELL SITE LAYOUT:
 - A. Exhibit "C" indicates the relation location and dimensions of the well pad, mud pits, reserve pit and major rig equipment.
 - B. The location slopes to the west.
 - C. The reserve pit will be lined with plastic to prevent loss of water.

10. PLANS FOR RESTORATION OF THE SURFACE:

- A. After completion of drilling and/or completion operations, all equipment and other material not needed for operations will be removed. Pits will be filled and the location cleaned of all trash and junk to leave the well site in an aesthetically pleasing condition as possible.
