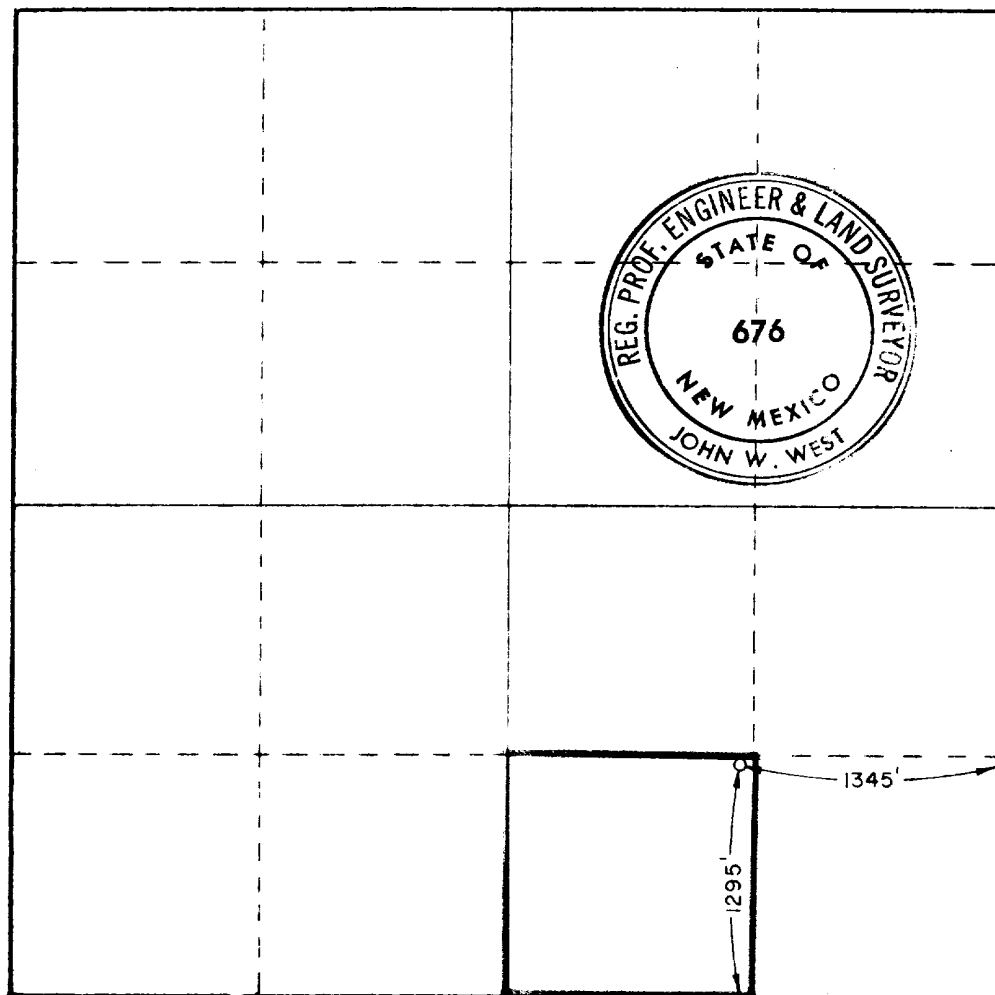

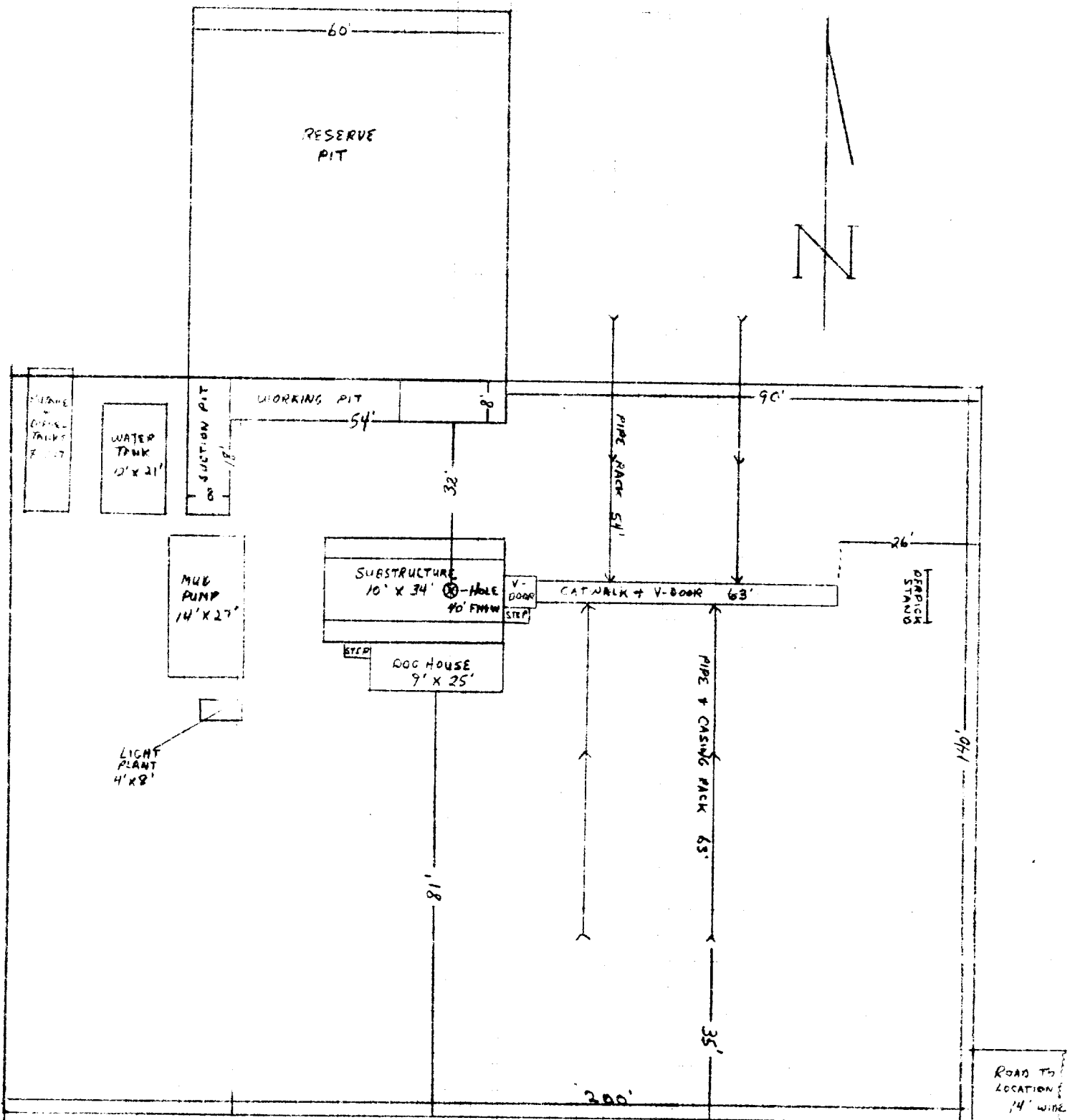

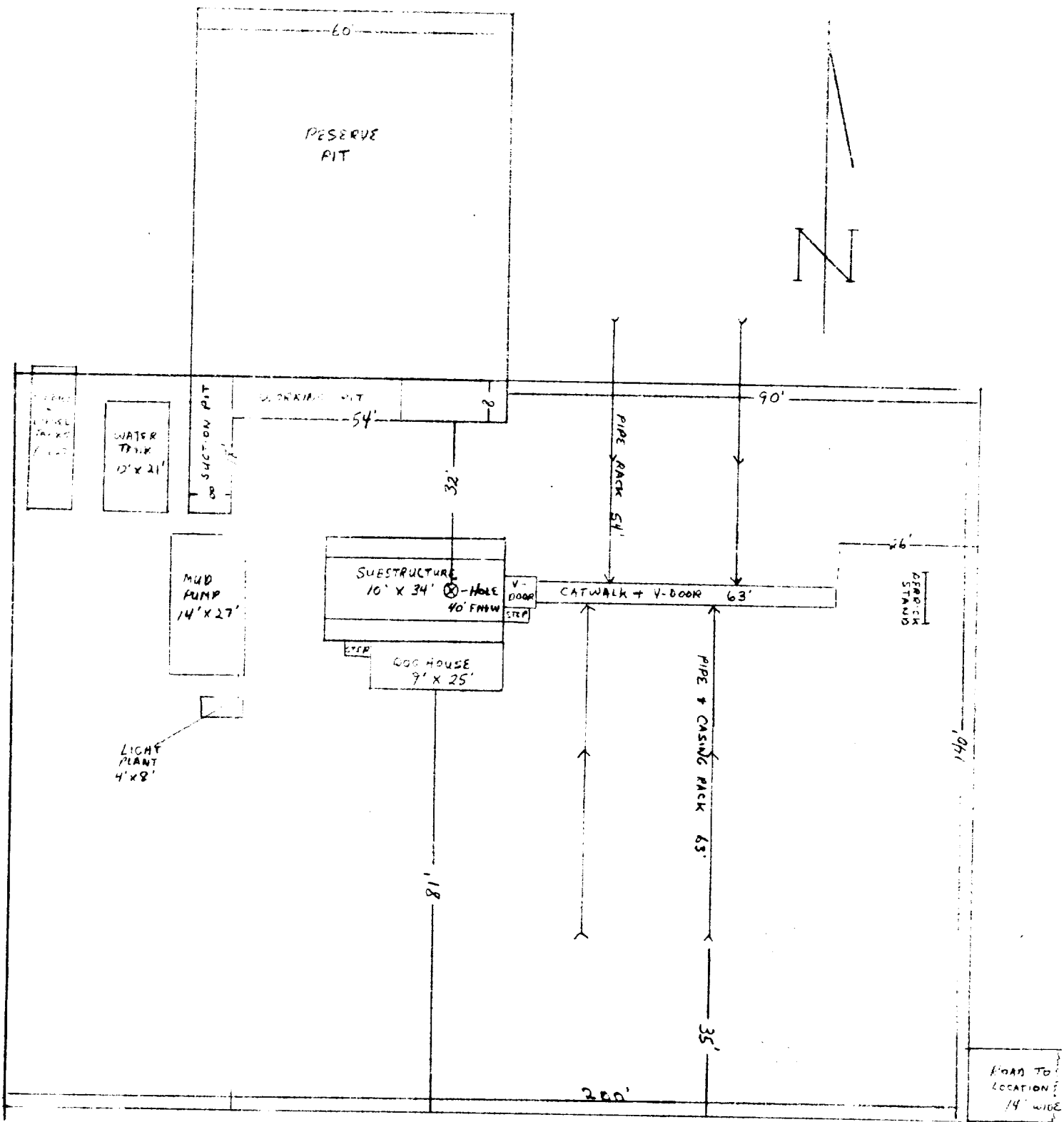

Section 19 Twp. 17-S Rge. 30-E Eddy County, New Mexico

1. Existing roads are shown on Exhibit "A".
2. Planned access roads are shown on Exhibit "A". The small amount of new construction required will be surfaced with caliche.
3. The location of existing wells and the proposed wells are also shown on Exhibit "A".
4. Lateral roads to well locations are shown on Exhibit "A".
5. Location of tank batteries and current flowlines are shown on Exhibit "A". Proposed flowlines are also shown. No new tank batteries will be necessary. New flowlines will be laid on top of the ground or buried along road right-of-ways and no special right-of-ways are planned for the flowlines.
6. Water supply for drilling will be either trucked or through pipe lines laid on road right-of-ways. No special right-of-ways will be made for water lines.
7. Waste disposal will be handled by an approved method at such time as it becomes necessary.
8. No Camps will be made.
9. No Airstrips will be made.
10. Location and layout including position of the rig, mud tanks, reserve pits, pipe rack, etc. are shown on Exhibit "B".
11. All pits used for drilling will be levelled back to their natural contours after they have dried.
12. The general topography of the drill sites are flat to very gently rolling land covered with sand dunes. The vegetation is mostly mesquite bushes, shinnery and a very small amount of grass.

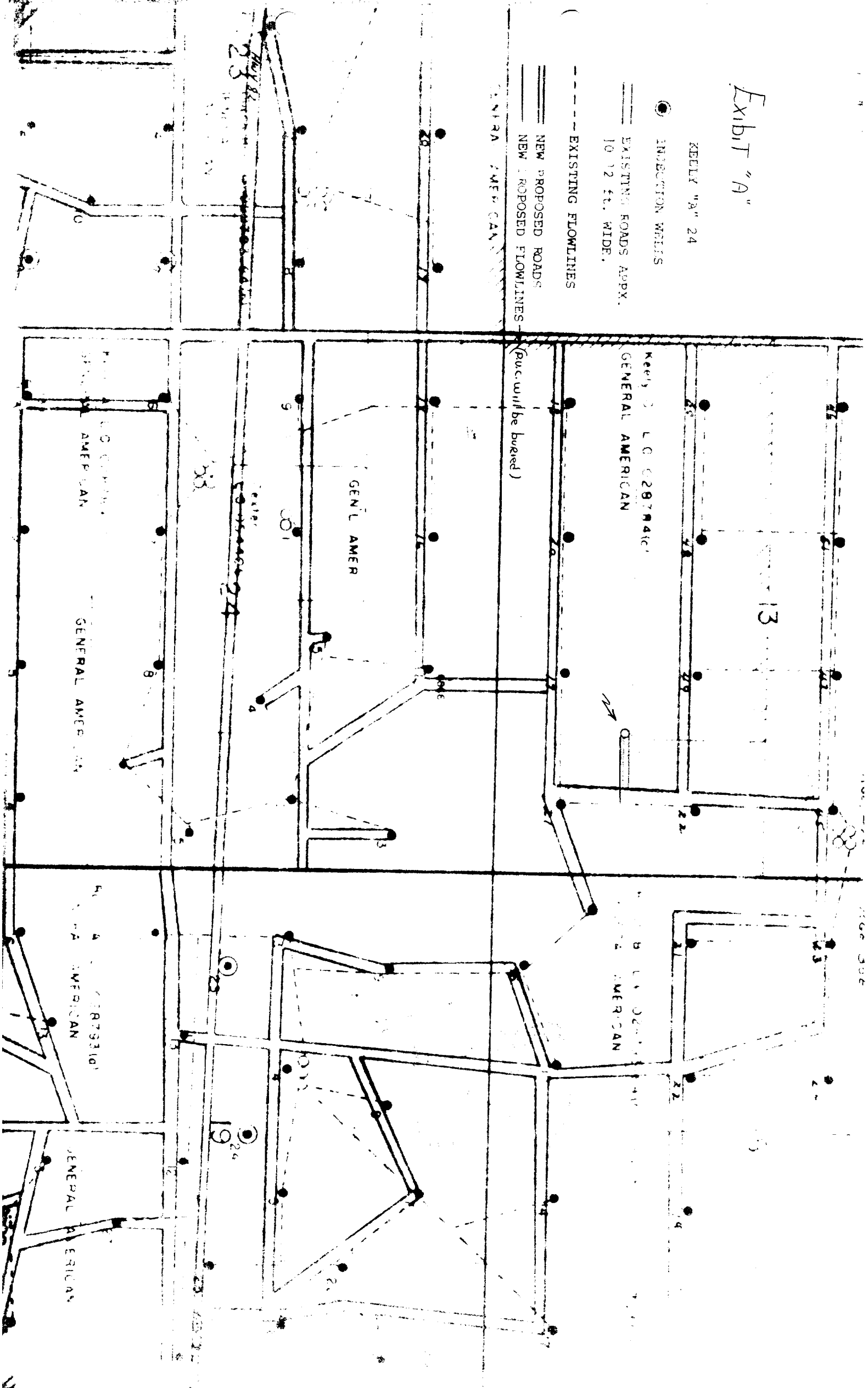
