Yates Petroleum Corporation proposes to drill and test the Delaware and intermediate formations. Approximately 250' of surface casing will be set and cement circulated. Approximately 3550' of intermediate casing will be set and cement circulated. If commercial, production casing will be run and cemented with adequate cover, perforated and stimulated as needed for production.

MUD PROGRAM: Native mud to 250'; Brine to 3550'; cut Brine to TD.

BOPE PROGRAM: BOPE will be installed at the offset and tested daily to assure good mechanical working order.
