The well above is not drilled, but an APD was filed by Penwell Energy, Inc. Concho Resources Inc. respectfully requests an operator change on the APD.

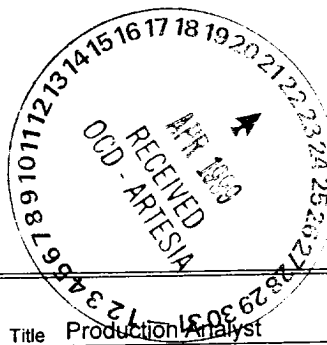
