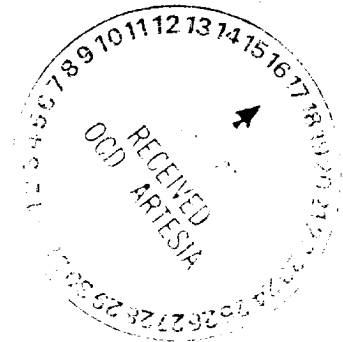

hereby applies for a right-of-way easement for construction and location of a 6" steel pipeline to carry natural gas and produced liquids to an existing gathering line across Section 4, T17S, R28E, Eddy County, New Mexico including a 6" valve setting and 4" meter run.

(type of line or facility, for pipeline give o.d.)

It is requested that the right-of-way be 50 feet wide, as indicated on the attached two copies of survey maps or plats, which show in red, except for saltwater disposal applications, the survey centerline and the length of the right-of-way measured in rods. Also, enclosed is the legal description of the proposed right-of-way allocated by 40 acre tracts and a computation of the number of acres included in the proposed right-of-way.

If the right-of-way is desired for a period other than thirty-five years, state the duration for which the grant is sought and, if over thirty-five years, the reason why the longer period is necessary:

One of the following is enclosed to cover payment for any damages that might accrue to the state land or improvements of a surface lessee:

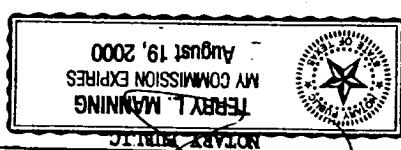

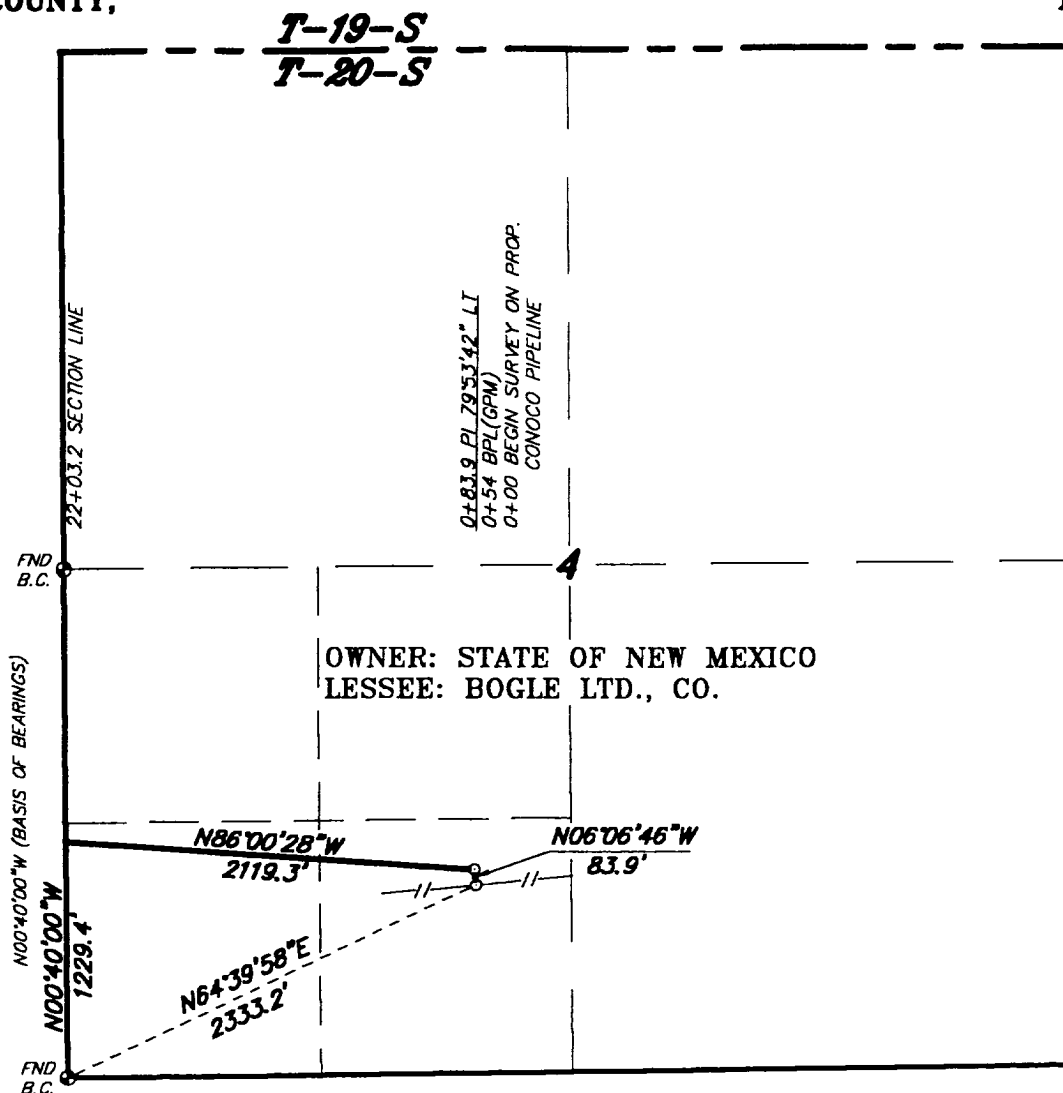
