Proposed perforations are: MV - 3680' - 6299' ; DK - 8055' - 8294' These perforations are in TVD.

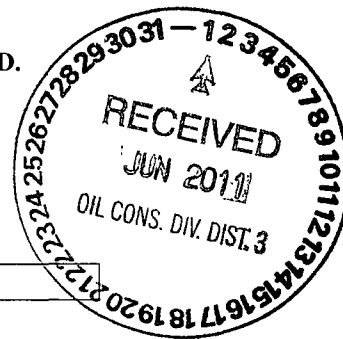
