Dear Ms. Fields,

I have received two notifications from LT Environmental regarding the Stage 1 Abatement Plan filed by Hilcorp Energy Company for Standard #1 in San Juan County, NM. I own 2 parcels that are within 1 mile of the Standard #1 site.

From the information in the notification, I have attempted to locate the site from San Juan County Assessor's Office mapping, but I am not certain of the accuracy. I have also tried to review the copy of the Stage 1 Abatement Plan on the NMOCD's public database without any success. I am not sure that the notice had adequate instruction for me to do this, but in any case, I am not able to obtain the information. I have left a message for Jennifer Deal with Hilcorp Energy Company requesting a call back to obtain information from her, but have not yet heard from her. Can you please help me get information on this matter? I would like information on location, status and scope of the pipeline spill/release and I would like to be included in all correspondence related to the findings and remediation. I am concerned because I have significant and valuable acreage near this site and I believe that my properties are located between the river and the site of the spill, and thus, likely in the drainage path of any spill.

Hilcorp Energy Company (Hilcorp) announces publication of a Stage 1 Abatement Plan for soil and groundwater impacts identified at the Standard #1 natural gas production well located at latitude 36.7536011 degrees (°) and longitude -108.1002121° in Unit J of Section 4 of Township 29 North, Range 12 West in San Juan County approximately 3 miles southwest of Flora Vista, New Mexico.

On November 28, 2017, a historical release of unknown volume of natural gas condensate and produced water from a production pipeline was identified by Hilcorp during maintenance activities. Initial source removal and subsurface investigation indicated soil in the vadose zone and shallow groundwater occurring at approximately 25 feet to 35 feet below ground surface are impacted above applicable remediation standards defined by the New Mexico Oil Conservation Division (NMOCD). The current extent of subsurface impact is estimated to be 1.5 acres; however, full delineation is not yet complete. No surface water was impacted.

The Director of the NMOCD has approved a Stage 1 Abatement Plan in which Hilcorp proposes to complete delineation through additional soil borings and monitoring well installation, from which soil and groundwater will be sampled and analyzed for contaminants. The data obtained from the Stage 1 Abatement Plan will be combined with previously collected subsurface data to complete characterization of the soil and groundwater impacts and to design appropriate remediation. In determining that the Stage 1 Abatement Plan is administratively complete, the NMOCD Director has complied with Subsection B of 19.15.30.15 of the New Mexico



Administrative Code (NMAC) by reviewing the document and concluding that it satisfies the requirements of Subsection C of 19.15.30.13 NMAC.

Members of the public may view a copy of the Stage 1 Abatement Plan at the NMOCD's Santa Fe office at 1220 South St Francis Drive, # 3, Santa Fe, New Mexico or at the NMOCD's district office at 1000 Rio Brazos Road, Aztec, New Mexico. Additionally, the Stage 1 Abatement Plan is available for viewing electronically on the NMOCD public database at <http://www.emnrd.state.nm.us/OCD/>.

The NMOCD is accepting written comments and requests for consideration if the NMOCD Director receives them within 30 days after the date of publication of this public notice. A person seeking to comment on a stage 1 abatement plan should submit written comments to:
