The release site is located at UL L Section 24 T25N R5W; 36.385225 -107.320180. An area of approximately 10 feet long by 10 feet wide, around the blow out hole was affected by the released fluids. Also, fluids ran down a bar ditch along the dirt road for about 120 feet. Enterprise has blown down, depressurized, and LOTO the pipeline. Enterprise has recovered the released fluids as much as practicable and barricaded off the affected areas. I will
