Good afternoon Cory,

This email is to notify NMOCD of Harvest's intention to re-use the stockpiled soils from the Trunk S excavation at Harvest's Lybrook facility off of US Hwy 550. The soil will be staged at the facility and used to repair areas eroded by recent rain events within the facility boundary. The coordinates for the Lybrook facility are (36.231980, -107.547740) and the location is identified below:



The USGS 7.5-minute topographic quadrangle (Lybrook) of this region (accessed at <https://apps.nationalmap.gov/downloader/#/>) shows that the nearest significant watercourse, designated by a dotted blue line, is located approximately 980-1,000 feet to the north of the proposed soil placement area:



The soil placement is scheduled to take place before the end of September before hunting season starts. Soil will be transported from Trunk S to the Lybrook facility by Harpole Construction.

Once this work is complete, a follow-up email will be sent to NMOCD as soil is placed around the facility, but at no point will soil be used outside of the boundary indicated in red below.
