Turned over to rigless operations. Ran GR/CCL/CBL. RU Blue Jet & perforate MV @ 1 spf .34" holes - 5806', 5687', 5680', 5665', 5618', 5607', 5574', 5562', 5559', 5545', 5535', 5527', 5523', 5514', 5509', 5424', 5359', 5348', 5342', 5301', 5293', 5284', = 22 holes total. Acidized perms w/1500 gal 15% HCL. RU to frac. Pumped 57,329 gal 60 Quality N2 30# X-link Spectra foam w/200,920# 20/40 Brady sand & 753 mscf N2. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment. Turned well over to production to flow test up the casing. Plans are to D/O CIBP, run tubing and DHC around the end of the year.
