Perforated MV @ 1 spf .34" holes - 5987', 5927', 5923', 5910', 5889', 5851', 5845', 5815', 5803', 5786', 5783', 5775', 5770', 5759', 5748', 5737', 5731', 5666', 5611', 5607', 5559', 5543', 5498', 5495', 5487', 5478', 5475', = 27 holes. Acidized perms w/1500 gal 15% HCL. RU to frac. Pumped 146,000 gal of 60 Quality N2 slickwater foam w/1.56 mm scf N2 and 150,040# 20/40 Brown sand. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment. RIH w/mill & C/O fill to CIBP @ 6500'. D/O CIBP. C/O to 8041' (PBTD). COOH w/mill. RIH w/2-3/8", 4.7# tubing and set @ 7993' w/"F" nipple set @ 7985'. ND BOP, NU WH. Pumped off expendable check. RD & released rig 12/1/02. Turned over to production. Well DHC'd on 12/5/02 per DHC Order #975 AZ.
