Drilled 6-1/4" hole to 4749'. TIH w/4-1/2" 10.5# J-55 STC csg & set @ 4749'. Cemented 1st stage w/70 sx (200 cf) San Juan Poz w/4% gel, 0.15% Fe2, 0.2% Halad 9, mixed @ 10 ppg, 2.86 cf/sx. Tail w/225 sx (328 cf) 50/50/B/Poz w/3% gel, 0.8% Halad 9, 0.2% CFR3, 5#/sx of Gilsonite and 1/4#/sx Flocele mixed @ 13 ppg, & 1.46 cf/sx. Opened DV tool @ 3803' and circ. 10 bbls cmt to surface.

Lead 2nd cement stage w/70 sx (200 cf) San Juan Poz w/4% gel, 0.15% Fe2, 0.2% Halad 9 mixed @ 10 ppg and 2.86 cf/sx. Tailed in w/740 sx (1776 cf) STD w/2% Econlite, 2% Versasat, 0.8% Halad 9, 5#/sx Gilsonite, and 1/4#/sx Flocele mixed @ 12 ppg w/yeild 2.4 cf/sx. Followed by 110 sx (134 cf) STD w/5#/sx gilsonite & 1/4#/sx Flocele mixed at 15.4 ppg w/yeild of 1.22 cf/sx. Circulate 20 bbls cement to surface.
