Load & PT casing to 1000 psi - 10 minutes OK. Changed out tbg head. RIH w/mill & tagged top of packer'. Milled and chased debris to 7569' (4" liner top). COOH. RIH w/taper tap to fish packer. COOH w/Packer. No fish left in hole. RIH w/bit & C/O 4" liner to 7804' (PBTD). COOH. RIH w/retrievable packer & set @ 7628'. Acidized DK perfs w/1500 gal 7.5% HCl. Released packer & COOH w/packer.
