It is intended to add the Menefee to the existing Mesaverde perfs as follows:

1. MIRU. TOH with tubing.
2. Set CIBP above the top Point Lookout perf. Test Casing to 3000 psi.
3. Selectively perforate Menefee per Geological recommendation and fracture treat with 60Q foam.
4. Flow back until well cleans up.
5. TIH, drill out CIBP and clean out to PBTD.
6. TIH with tubing and land 1 joint above bottom Mesaverde perf.
