1. MIRU. TOH with pump, rods and tubing.
2. Set a RBP at 6800'. Pressure test casing to 3000 psi.
3. Run a GR-CCL-CBL log across the Mesaverde.
4. Selectively perforate the Mesaverde from 5730-6100'. Fracture treat with 60Q Foam.
5. Flow back frac and clean out wellbore with air mist.
6. Release RBP and TOH.
7. TIH and clean out to PBTD. Land tubing at 8100'. Run pump and rods.
8. Return to production as a Mesaverde/Gallup-Dakota Down-hole Commingle.


