Please reference BLM letter of February 27, 2004, requesting permanent abandonment of the Dakota formation in the subject well. The subject well was temporarily abandoned in 1994, and as a condition of the completion of the Florance AB 31M well into the Dakota in October 2002, the Dakota was required to be abandoned (no production allowed). However, due to an error in our accounting procedures the Mesaverde and Dakota horizon codes for BLM reporting purposed were switched and production was inadvertently reported to the Dakota instead of the Mesaverde. We are in the process of making corrections and corrected production reports will be submitted to the BLM. Therefore, we respectfully withdraw our request of March 17, 2004, to permanently abandon the Dakota and request to maintain the Dakota formation in a temporary abandonment status until such time as conditions warrant permanent abandonment.
