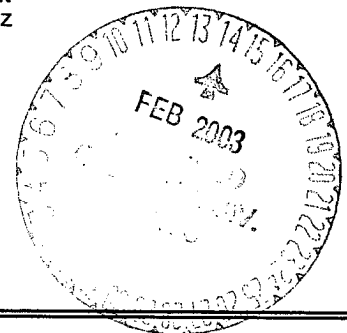

Sqz held OK.
