2/6/03 MIRU Key #49. Spud 12-1/4" hole @ 0600 hrs 2/7/03. Drilled ahead to 545'. Circ. hole. RIH w/9-5/8", 36# J-55 casing and set @ 535'. RU to cement. Pumped a preflush of 5 bbls FW, & 10 bbls FW/dye. Pumped 310 sx (372 cf - 66.3 bbl slurry) Standard cement w/2% CaCl2 & 1/4#/sx Flocele. Released wiper plug and displaced plug w/38.3 bbls FW. Bumped plug @ 2040 hrs 2/7/03 w/320 psi. Circ. 28 bbls cement to surface. WOC. NU WH & NU BOP. PT casing to 1500 psi for 30 minutes with FW. After 5 attempts couldn't get an acceptable PT. Contacted Charlie Perrin & he instructed them to run packer & test casing. RIH w/tension packer & set @ 450'. RU tester to BOP test port. Filled BOP & drillpipe w/FW. Closed pipe rams and PT casing to 1500 psi w/water for 30 minutes with zero pressure loss. Acceptable test for NMOCD and reported test to O&G Admin - Jicarilla Apache tribe.
