Move in, rig up. Trip out of hole with tubing. Set a retrievable bridge plug above existing Mesaverde interval. Pressure test the casing. The Pictured Cliffs interval will then be perforated and stimulated. The wellbore will be cleaned out to plug back total depth. Production tubing will be run. The well will be commingled. A down hole commingle application will be submitted.
