12/11/02 MIRU. TOH with 2-3/8" tubing.

12/12/02 Run GR/CCL 3900'-3550'. TIH with RBP, set @ 4170'. Test casing to 3000 psi-ok. Perforate Pictured Cliffs 3730'-3776' with 48 holes.

12/14/02 Acidize perfs with 1000 gals 15% HCL. Frac with 20,615 gals 70Q foam & 75,000# 20/40 sand.

12/15-16/02 Flow back after frac. TIH. Clean out to RBP and retrieve RBP.

12/17/02 TIH. Clean out to 6218' with air mist. TOH.

12/18/02 TIH with 2-3/8" tubing, land @ 5969'. NU wellhead. Return to production.
