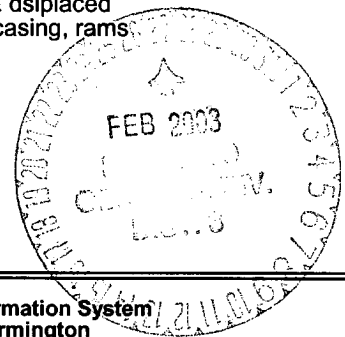

Released wiper plug & dsplaced w/14.2 bbls FW. Circ. 13 bbls cement to surface. RD Halliburton. WOC. NU BOP, PT casing, rams, and manifold to 600 psi - 30 minutes. Good test.
