Spud 8-3/4" hole @ 1100 hours on 2/3/03. Run 3 jts of 7" 23# J-55 casing, set @ 124'. Cement w/50 sx Class "B" neat w/1/4# celloflake/sx & 2% CaCl (59 cu ft total). Circ 2 bbls of cement. Test casing to 600 psi, held.
