Cement casing as follows: First stage w/235 sx Premium Lite HS (Class H/poz/gel) w/1/4 pps celloflake, 0.3% Retarder, 0.5% fluid loss, 0.2% dispersant, 2% KCl & 2% Phenoseal mixed @ 12.5 ppg, 2.01 cuft/sx & 10.55 gal/sx). DVD tool @ 4,800'. Second stage: Lead - 340 sx Type III cement w/8% gel, 2% Phenoseal & 1/4 pps celloflake mixed @ 11.4 ppg, 3.03 cuft/sx & 18.51 gal/sx. Tail - 100 sx Type III cement neat mixed @ 14.5 ppg, 1.39 cuft/sx & 6.81 gals/sx.

All volumes include 40% excess.
