This well was returned to production 1/23/03. Oil production is now at 3%. We expect that oil will continue to increase as additional fluid is produced from the Gallup. We request that 60 days be allowed to continue evaluation of the Gallup. Dugan is moving to drill a Fruitland Coal well on this lease. A Notice of Staking will be filed immediately. We will diligently pursue the drilling and completion of the coal well.
