- MIRU. TOH laying down 1-1/2 tubing.
- Set RBP at 7800 . Test Casing to 3000 psi.
- Selectively perforate Gallup per Geological recommendation and Fracture treat with foam.
- Flow back until well cleans up.
- TIH, clean out to RBP. Retrieve RBP.
- TIH with 2-3/8 tubing and land at bottom Dakota perf.
- Return to production.

A revised well location plat is attached showing the Gallup dedication.
