Surface terrain allows for pre-set of the 9 5/8 casing on the above mentioned well. Verbal approval to pre-set was obtained by Rich Vecellio from Adrienne Garcia (BLM) on 3/26/2004. Pre-set surface casing calls for drilling a surface hole with air/air mist in lieu of drilling mud and the surface casing be cemented with 94.5 cu/ft type I-II, 20% FLYASH, 14.5 PPG, 7.41 gal/sk, 1.61 cf/sk Yield, ~~NO-DEC-01ST~~ ready mix cement.
