Plug down @ 8:45 AM on 01/13/02. Circulate 9 bbls cement to surface.. Drilled 7-7/8 to 7395' KB. TD reached @ 10:30 AM on 01/31/02. Ran Halliburton High Resolution Induction Log, Dual Spaced Neutron Log and Acoustic Cement Bond Log. Ran 170 jts 4-1/2, 11.6# J-55 LTC casing set @ 7398' KB. Cemented with 1100 sx Class "B". Circulate 3 hours and 47-1/2 bbls to surface. Drop plug and close tool with 3000 PSI. Rig down cementers. Set slips. Cut off casing. Release rig. Install wellhead. R/U American Energy Services and frac Dakota w/1995 bbls AmborMax 1025 and 138,000 #s 20/40 Brady Sand. ISIP - 390. ATP - 2670. AIR - 54 BPM.
