Premium Lite FM, 2% bwoc Calcium Chloride, 0.25 lb/sx Cello Clake, 5 lb/sx LCM-1, 6% bwoc Bentonite,

98% Fresh Water. Circ 25 bbl scavenger & 45 bbl cement. WOC.
