Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped Lead - 405 sx (1057 cf - 188.3 bbl slurry) Class G cement w/3% chemical extender, 0.25#/sx Cellophane flake, 0.05 g/s Antifoam agent & 0.2% all purpose anti-foam. Tail - 100 sx (127 cf - 222.6 bbl slurry) 50/50/G/POZ cement w/2% Bentonite, 2% CaCl<sub>2</sub>, 5#/sx Gilsonite, 0.25#/sx Cellophane flake & 0.1% antifoam agent. Released wiper plug and displaced 20.0 bbls FW & 104.0 bbls slightly polymerized drill water. Bumped plug w/1450 psi @ 1852 hrs 4/1/04. Circ. 34 bbls cement to surface. Flush BOP & WH. RD & released Schlumberger. ND BOP, set slips and cut off casing. Installed trash cap. RD & released rig @ 2400 hrs 4/1/04. Will show casing PT on next report.
