3/28/04 RIH w/8-3/4" bit & tag cement @ 195'. Drilled cement and then formation to 3945'. Circ. hole. RIH w/7", 20#, J-55 ST&C casing & set @ 3945'. RU Halliburton to cement. Pumped a preflush of 20 bbls water w/dye in last 10 bbls. Pumped 400 sx (1152 cf - 205 bbl slurry) STD, 3% Econolite, 10#/sx Phenoseal. Tail- 230 sx (306 cf - 54.49 bbl slurry) 50/50 STD/POZ, 2% Bentonite, 6#/sx Phenoseal. Dropped plug and displaced w/156 bbls water. Bumped plug w/1400 psi, plug down @ 1600 hrs 3/31/04. Circ. 45 bbls good cement to surface. RD Halliburton. Washed cement out of BOP stack. WOC. ND BOP, set slips and cut off casing, NU BOP, PT-OK. PT casing to 1800 psi for 30 minutes. Good test.
