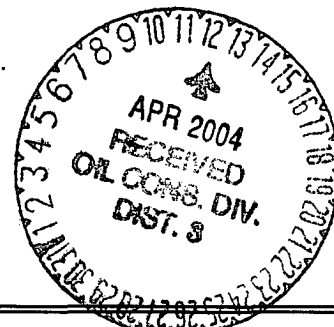

We intend to return this well to production as follows:

- 1) MIRU. TOH w/ 2-3/8" tubing.
- 2) TIH w/ 4-1/2" packer on 2-3/8" tubing. Set packer at 6280'.
- 3) Test casing to 500 psi. If test fails, isolate casing leak and squeeze off with cement.
- 4) Swab well in and return to production.
