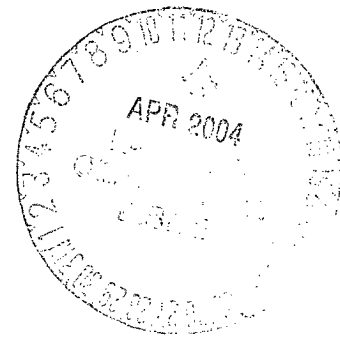

- 3) TIH with 2-3/8" tubing and land at bottom Chacra perforation.
- 4) Return to production.
