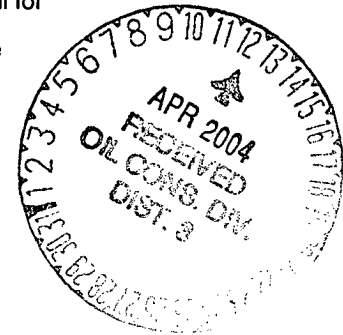

Upon positive results of evaluation, proposed procedure and application for permission to surface commingle will be submitted. We anticipate bringing this well back to production status in 4th qtr of 2004.
