Four Star Oil and Gas intends to perforate and fracture the Basin Fruitland and commingle downhole with the S Blanco Pictured Cliffs as follows:

MIRU Workover Rig. ND wellhead and NU BOP and pressure test same. Kill well, and POOH with 2 3/8" tubing. Set Bridge Plug at 2010'. Test 5 1/2" casing. If casing test fails evaluate for P&A or repair.

If casing test successful, perforate the Fruitland Coal from 1986'-1914' with two (4) shots per foot adding 140 holes. Fracture treat the formation with 92,316 gals of 20# Delta 140 Frac fluid and 175,000 lbs 16/30 Brady sand.

Flow and clean up well. PU 3 7/8" bit and 2 3/8" tubing. Circulate clean to PBTD at 2010', drill out bridge plug. POOH with tubing. RIH with production string. RIH with pump and 3/4" sucker rods. ND BOP. NU wellhead. RDMO workover rig.

Hook well up to sales and place well on production.

- ii) The two pools to be commingled are the ~~Blanco~~ <sup>41' 2'</sup> (Pictured Cliffs) and the Basin (Fruitland Coal).
- iii) The perforations are at 2110'-2040' <sup>S Blanco</sup> (Pictured Cliffs) and 1986'- 1914' (Fruitland Coal).
- iv) The production will be allocated using the subtractive method.
- v) Commingling will not reduce the value of the remaining production.
- vi) Interests in the two zones are the same.
