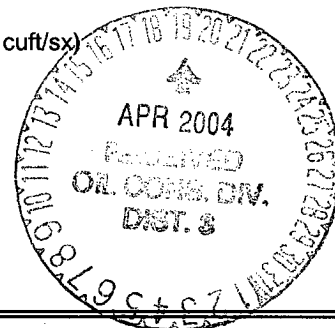

- 6) PT csg to 2000 psig. Pressured dwn & held @ 550 psig for 30 min. OK.
- 7) SWI overnight.
- 8) TIH w/NC, SN, tbg. EOT @ 6408'.
- 9) PT tbg to 1000 psig. Held OK.
- 10) TIH w/NC, SN, tbg. EOT @ 6469'.
