It is intended to restimulate the Pictured Cliffs formation in the existing well as follows:

Move in, rig up. Pull tubing and packer. Set a retrievable bridge plug above the Pictured Cliffs perforations. Pressure test the casing. Pull the retrievable bridge plug. The Dakota will be isolated with a retrievable bridge plug and the Pictured Cliffs interval restimulated. The wellbore will be cleaned out to plug back total depth. The well will then be commingled. A down hole commingle application will be submitted.
