Cement casing as follows: First stage w/275 sx Premium Lite HS (Class H/poz/gel) w/1/4 pps celloflake, 0.3% retarder, 0.5% fluid loss, 0.2% dispersant, 2% KCl & 2% Phenoseal mixed @ 12.5 ppg, 2.01 cuft/sx & 10.55 gal/sx followed by 100 sx Type III cmt w/5% BA-10, 1/4# cello, 0.3% CD-32, 0.2% FL-52 2% Pheno @ 14.2, 1.54 cuft/sx. DVD tool @ 4150'. Second stage: Lead 290 sx Type III cmt w/8% gel, 2% Phenoseal & 1/4 pps celloflake mixed @ 11.4 ppg, 3.03 cuft/sx & 18.51 gal/sx. Tail - 100 sx Type III cmt neat mixed @ 14.5 ppg, 1.39 cuft/sx & 6.81 gals/sx. All volumes include 40% excess.
