01/28/03 Change wellhead from single to dual wellhead. Perforate PC 3980' - 4070' - 1JSP2' - 45 holes.

01/29/03 Acidize with 1000 gals 15% HCL.

01/31/03 Frac PC perfs with 116,040 gals 70Q foam & 121,691# 20/40 sand. Flow back frac.

02/04/03 TIH. Clean out with air mist to RBP. Retrieve RBP. TOH.

02/06/03 TIH. Clean out to PBD. TOH.

02/11/03 TIH. Ran 202 jts. 2-3/8" tubing, set @ 6251'. Set Baker Model R packer @ 4766'. Ran 129 jts. 1-1/2" tubing, set @ 4072'. ND BOP. NU wellhead. Return to production.
