The subject well was temporarily abandoned 3/17/97 (see sundry dated 3/25/97). After the plug was set, we had a good pressure test to 500 psi for 30 minutes. We will be adding corrosion inhibited fluid to the wellbore immediately. Phillips wishes to extend this TA status approval to the maximum limit allowed. Plans are to keep the wellbore available for sidetrack in the event we loose production from the other wells in this area.
