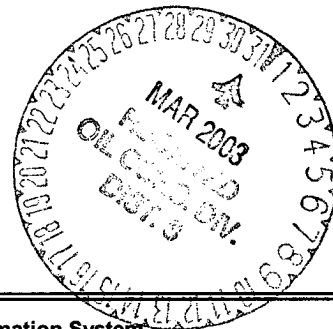

It is intended to add the Chacra formation to the existing wellbore. The existing formations will be isolated and the Chacra interval perforated and fracture stimulated. The wellbore will be cleaned out to plug back total depth. All formations will then be commingled using a single string of tubing. A down hole commingle application will be submitted.
