

4/6/04 Set RBP @ 5707'. Ran GR-CCL-CBL from 868-3930'. Perforate PC from 3664-74'.
4/7/04 Pump 1028 gals 15% NEFE acid and frac w/33167 gals 70Q 20# linear gel and 33167# 20/40 sand. Flow back well.
4/8-10/04 Flow back and CO well to RBP @ 5707'. Retrieve RBP and TOH.
4/12/04 CO to PBTD. Landed tubing @ 5906'. Rig down.
