Pressure tested casing to 3500 psi, held ok. Perforated Fruitland Coal 1762'-1772' w/4 shots/ft. Fractured w/borate gelled water. Frac did not go to completion. Approximately 2400# of sand was placed into the formation. The same interval was re-perforated w/2 shots/ft. A second frac job went to completion using 39,875# of 20/40 sand and 12,000# of 20/40 Resin coated sand in 34,500 gals of AmBor Max 1020 gelled water. The re-frac was completed 4/22/04. Production tubing and rods were run on 4/29/04.
